1.2 All members engaged in water based activities must also be registered with Canoeing Ireland for insurance purposes. All adults who assist in club activities must register as Associate members.

1.4 No fees will be charged for paddling sessions this year. This will reduce the need to handle cash at sessions.

## **Tullamore Canoe Club**

### **TuCC Membership rules**

1. All members must abide with all TuCC rules on safety, procedures, GDPR Requirements, Non-Discrimination, Fair play, membership, Event Guidelines and other policies. TuCC policies are liable to change and will be re-issued as required.
2. By signing the TuCC Membership form members agree to accept the terms and conditions as laid out in TuCC policies.
3. Parents or Gaurdians, by signing the membership form, agree to abide by TuCC Junior Members Consent terms and conditions.
4. TuCC events will be offered on the basis of experience and water levels, at the discretion of the club instructors. Events may be cancelled or postponed at the discretion of the club. The club has the right to refuse entry to the water any member who, in the opinion of the club instructors, is not suitable attired for the trip, or may compromise the safety of themselves and/or the rest of the group.
6. Access to TuCC events and facilities is restricted to TuCC members except where TuCC host events open to the public or where the Steering Committee invites individuals or groups.
7. All members provide consent for storing personal information and for using photos of events for TuCC's publicity purposes or advertising media. TuCC GDPR policies dictate all responsibilities and services involved.

### **TuCC Junior Members Consent**

1. I authorise my child(ren) to take part in activities of the Tullamore Canoe Club. The Instructors, leaders, helpers and club organisers have permission to act in place of the parent/guardian. While my child(ren) is under their supervision I agree to fully exempt the instructors, leaders, helpers and club organisers from any liability for accident, injury and/or death to my child(ren) while pursuing the activities of the club.
2. I authorise Tullamore Canoe Club to administer general first aid treatment for minor injuries or illness experienced by the Child(ren) during club activities.
3. I authorise Tullamore Canoe Club, in the event that I cannot be contacted or if any urgency dictates, to act in the best interests for the Child(ren) in respect of any circumstances, including accident or illness, which may necessitate medical treatment, including surgery, and on my behalf to authorise any such treatment or surgery which they, in their sole discretion, (which discretion shall not be unreasonably exercised), may deem necessary provided any such medical treatment is performed by a duly licenced practitioner.
4. I authorise Tullamore Canoe Club to publish canoeing related images including photographs and film of my child(ren) on the club website, the club Facebook page, in club publications and in local or national print or electronic media.
5. I acknowledge that Tullamore Canoe Club is in no way responsible for canoeing/kayaking activities which my Child(ren) may participate in outside of official club events, regardless of my Child(s) use of club equipment at the said event.

### **Parents/Gaurdians are expected to:**

- a) Inform the event leader at the start of every event of any health issues pertaining to their child. In Particular, make the leader aware of any medications, (inhalers etc.) which the child needs to carry during the event.
- b) Deliver and collect their child to and from the event. The Club, its leaders, helpers or other adult members are not responsible for the child before getting on the water or after getting off the water. It is recommended that parents/guardians of children under the age of 14 remain on site during activities.
- c) Ensure that their child is properly clothed for the activity, taking into account weather conditions.
- d) Ensure that their child has adequate nutrition for the duration of the activity.
- e) Accompany their child on any overnight activities or trips.
- f) Abide by the recommendations of the Tullamore Canoe Club Code of Conduct.

### **TuCC Indemnity Statement.**

I in consideration of being admitted to Tullamore Canoe Club and allowed to use its equipment, hereby undertake to indemnify the Club against all liability of any kind to myself or to other persons in respect of death or injury (including that due to neglect or fault of the club, its members, servants or agents) suffered by me as a result of using its equipment, at any time, and I declare that this indemnity shall (in the case of my death) be a continuing one binding on my legal person, personal representatives and my estate generally.
