### CANOEING AT TuCC.

**Summer Season (1 April to 30 September):-** Level 2 training and proficiency will be held during these dates. Improver courses will be provided at local sites during these dates. Beginner and improver courses will NOT be offered outside of the summer season.

**Winter Season (1 October to 31 March):-** Courses and trips will be held for paddlers who have sufficient Level 2 experience during these times. Trips will be offered on the basis of experience and water levels, at the discretion of the group leader.

PLEASE NOTE – Tullamore Canoe Club at all times aims to provide enjoyable and safe paddling for all of its members. However, all events are dependent on conditions at the time, and may be cancelled or postponed at the discretion of the club. The club has the right to refuse entry to the water of any member who, in the opinion of the group leader, is not suitably attired for the trip, or may compromise the safety of themselves and/or the rest of the group.
